2. The condition for the proper registration of your participation in the congress is to read and accept these Participation Conditions.
3. These provisions apply to all congress participants.
4. The organizer will immediately notify you about any changes to these rules.

B. Venue and Date

1. The congress will take place from **21. - 24. May 2017**.
2. The venue of the congress will be JW Marriott Marquis Hotel Dubai, UAE.
3. The organizer reserves the right to change the congress date and place.

C. Participation Conditions and Registration

1. The condition for participating in the congress is to register by using the online form available online ([here](#)) and to pay the participation fee.
2. Within **7 days**, the organizer sends a confirmation that it has received the application for participation in the congress to the address given in the registration form. Yet, the participation will not be valid until the participation fee has been paid.

D. Payment

4. After payment is received on the organizer's account, the congress participation confirmation is sent, which completes the registration process.
5. The fee does not include the costs of transport to the congress venue. The travelling costs to Dubai and the congress venue must be undertaken by the participant.

E. Hotel Accommodation

1. The organizer does not cover the accommodation for the congress participants.

F. Participant's Resignation or Replacement

1. Resignation from participation in the congress is possible only through a resignation declaration sent by e-mail, fax, or registered letter to the organizer's address.
2. Resignation from the congress participation:
 - 31.03.2017: reimbursement of 50% payment
 - After 1.05.2017: there is no reimbursement of participation fees
3. Failure to cancel the participation will result in 100% payment being charged.
4. It is possible to replace the participant by entering a registered replacement participant on condition that the details of the replacement are sent by **15 April 2017**.

G. Other Provisions

1. The organizer reserves the right to change the congress program at any time and in any scope.
